The school library provides a variety of books and materials that are aligned with the educational objectives of the school. School administration, librarian(s), and the curriculum coordinators are responsible for selecting and purchasing new books and other materials for the library. The librarian(s) encourages students, classroom teachers, staff members, and parents to make recommendations of books and other materials that they would like to be included in the school library collection, and keeps a running list of requested materials to review for selection.

#### **Selection Criteria**

When selecting materials for the library, the following criteria shall be considered:

- The contribution to the educational needs and interests of the students and school community.
- The significance of the author and the text.
- The degree of entertainment value and interest for students.
- The accuracy of the information.

- Developmental appropriateness for the grade and interest level at which they are used.
- The variety of viewpoints and perspectives the work contributes.
- Should not be pervasively vulgar or obscene.

Librarians are responsible for responding to directives from a parent regarding his or her child's library selections.

If a parent believes that the selection of any school library material violates this policy, they should follow the procedures set out in the Parent Grievance Policy.
